- 1. A *Creditor/Claimant* entitled to attend and vote is entitled to appoint a proxy to attend and vote in their stead.
- 2. The Proxy Form may be completed electronically prior to printing for the signature of the creditor/claimant or their representative. Please ensure that the name, physical address and email address of the person being appointed as proxy is clearly stated. If the Proxy Form is lodged without a designated proxy, the Trustee who will be the Chairman of the FMOC will be deemed to hold the proxy for the *Creditor(s)/Claimant(s)* and may cast the vote(s) on their behalf.

- 4. To be valid, this Proxy Form and the power of attorney or other authority (if any) under which it is signed must be lodged with the Trustee by the latest 9:00 a.m. Eastern Standard Time (Jamaica Time) on Friday, 25 October 2024 at any of the contact information listed below:

- 6. If the Proxy Form is returned without any indication as to how the person appointed proxy shall vote, the proxy shall exercise his discretion as to how he votes or whether to abstain from voting.
- 7. To be effective, this Proxy Form must be signed by the appointer or his attorney, duly authorized in writing or, if the appointer is a corporation, must be under its common seal or be signed by some officer or attorney duly authorized on their behalf.
- 8. This Proxy Form is subject to stamp duty of J\$100.00. The stamp duty may be denoted by adhesive postage stamps.
- 9. In lieu of this Proxy Form, a corporate body or other legal person/entity may submit a Letter of Authorization on their letterhead duly executed by a director or an authorized officer with the seal or stamp affixed.
